In full or partial consideration for allowing me to participate in all related events and activities of the Canadian Motorcycle Association I hereby warrant and agree that:

- 1. I am familiar with and accept that there is the risk of serious injury and death in participation, whether as a competitor, student, official or worker, in all forms of motor sport and in particular in being allowed to enter, for any reason, any restricted area; and
- 2. I have satisfied myself and believe that I am physically, emotionally and mentally able to participate in each EVENT, and that my protective clothing, gear and equipment is fit and appropriate for my role as a participant in each EVENT; and
- 3.1 understand that all applicable rules for participation must be followed, regardless of my role, and that at all times during each EVENT the sole responsibility for my personal safety remains with me; and
- 4.1 will immediately remove myself from participation, and notify the nearest official, if at any time I sense or observe any unusual hazards or unsafe conditions or if I feel that I have experienced any deterioration in my physical, emotional or mental fitness, or that my protective clothing, gear or equipment, for continued safe participation in each EVENT.
